

# Firefly Learning: Data Processing Addendum

**THIS DATA PROCESSING ADDENDUM** is entered into as of the Addendum Effective Date by and between: (1) Firefly Learning Limited, a company incorporated and registered in England and Wales with company number 10115230 whose registered office is at 100 20 St Thomas Street, London, SE1 9RS, United Kingdom ("**Firefly**"); and (2) the customer who has entered into an agreement with Firefly to purchase user subscriptions for certain Firefly software-as-a-service products ("**Customer**").

#### 1. INTERPRETATION

- 1.1. In this Data Processing Addendum the following terms shall have the meanings set out in this Paragraph 1.1, unless expressly stated otherwise:
  - (a) "Addendum Effective Date" means the effective date of the Agreement.
  - (b) "Adequate Country" means a country or territory outside the European Economic Area that the European Commission has deemed to provide an adequate level of protection for Personal Data pursuant to a decision made in accordance Article 45(1) of the GDPR.
  - (c) "Agreement" means the Software as a Service Agreement entered into by and between the Parties into which this Data Processing Addendum is incorporated and forms a part.
  - (d) "Anonymised Data" means any Personal Data (including Customer Personal Data), which has been anonymised such that the Data Subject to whom it relates cannot be identified, directly or indirectly, by Firefly or any other party reasonably likely to receive or access that anonymised Personal Data.
  - (e) **"Business Day**" means any day which is not a Saturday, Sunday or public holiday, and on which the banks are open for business, in the United Kingdom.
  - (f) "Cessation Date" has the meaning given in Paragraph 9.1.
  - (g) "Customer Personal Data" means any Personal Data Processed by or on behalf of Firefly on behalf of Customer under the Agreement.
  - (h) "Data Protection Laws" means the EU General Data Protection Regulation 2016/679 (the "GDPR") and the Data Protection Act 2018, being the legislation implementing the GDPR in the United Kingdom (references to "Articles" or "Chapters" of the GDPR shall be construed accordingly).
  - (i) "Data Subject Request" means the exercise by Data Subjects of their rights under, and in accordance with, Chapter III of the GDPR.



- (j) "Data Subject" means the identified or identifiable natural person located in the European Economic Area to whom Customer Personal Data relates.
- (k) "Delete" means to remove or obliterate Personal Data such that it cannot be recovered or reconstructed, and "Deletion" shall be construed accordingly.
- (I) **"Personnel**" means a person's employees, agents, consultants or contractors.
- (m) "Post-cessation Storage Period" has the meaning given in Paragraph 9.2.
- (n) "Restricted Country" means a country or territory outside the European Economic Area that is not an Adequate Country.
- (o) "Restricted Transfer" means the transfer of Customer Personal Data from Firefly to a Subprocessor in a Restricted Country, where such transfer would be prohibited by Data Protection Laws without a legal basis therefor under Chapter V of the GDPR.
- (p) "Services" means those services and activities to be supplied to or carried out by or on behalf of Firefly for Customer pursuant to the Agreement.
- (q) "Standard Contractual Clauses" means the standard contractual clauses issued by the European Commission (from time-to-time) for the transfer of Personal Data from Data Controllers established inside the European Economic Area to Data Processors established in Restricted Countries.
- (r) **"Subprocessor**" means any third party appointed by or on behalf of Firefly to Process Customer Personal Data.
- 1.2. In this Data Processing Addendum:
  - the terms, "Controller", "Processor", "Personal Data", "Personal Data Breach", "Process" (and its derivatives) and "Supervisory Authority" shall have the meaning ascribed to the corresponding terms in the Data Protection Laws
  - (b) without prejudice to the specificity of clause 1.3, in the event that any Associated Schools are identified in the Agreement as recipients of the Services, the term "Customer" shall be construed in accordance with applicable terms of the Agreement (including clause 2.7 thereof) so as to refer to the Customer and each such Associated School (where the context permits and requires); and
  - (c) unless otherwise defined in this Data Processing Addendum, all capitalised terms shall have the meaning given to them in the Agreement.
- 1.3. Customer warrants and represents that it, and each Associated School, is subject to the territorial scope of the Data Protection Laws as determined in accordance therewith (including pursuant to Article 3 of the GDPR). Customer further agrees that



to the extent that it, or any Associated School, is not in fact subject to the territorial scope of the Data Protection Laws, this Data Processing Addendum shall be deemed automatically void, with respect to Customer or each such Applicable School(s) (as applicable), with effect from the Addendum Effective Date without requirement of notice.

#### 2. PROCESSING OF CUSTOMER PERSONAL DATA

- 2.1. In respect of Customer Personal Data, the Parties acknowledge that:
  - (a) Firefly acts as a Processor; and
  - (b) Customer acts as the Controller.
- 2.2. Firefly shall:
  - (a) comply with all applicable Data Protection Laws in Processing Customer Personal Data; and
  - (b) not Process Customer Personal Data other than:
    - (i) on Customer's instructions (subject always to Paragraph 2.7); and
    - (ii) as required by applicable laws.
- 2.3. Customer instructs Firefly to Process Customer Personal Data as necessary:
  - (a) to provide the Services to Customer; and
  - (b) to perform Firefly 's obligations and exercise Firefly's rights under the Agreement.
- 2.4. Annex 1 (*Data Processing Details*) sets out certain information regarding Firefly's Processing of Customer Personal Data as required by Article 28(3) of the GDPR.
- 2.5. Nothing in Annex 1 (*Data Processing Details*) confers any right or imposes any obligation on any Party to this Data Processing Addendum.
- 2.6. Where Firefly receives an instruction from Customer that, in its reasonable opinion, infringes the GDPR, Firefly shall inform Customer.
- 2.7. Customer acknowledges and agrees that any instructions issued by Customer with regards to the Processing of Customer Personal Data by or on behalf of Firefly pursuant to or in connection with the Agreement:
  - (a) shall be strictly required for the sole purpose of ensuring compliance with Data Protection Laws; and
  - (b) (without limitation to the generality of Paragraph 2.5) shall not relate to the scope of, or otherwise materially change, the Services to be provided by Firefly under the Agreement.



- 2.8. Notwithstanding anything to the contrary herein, Firefly may terminate the Agreement in its entirety upon written notice to Customer with immediate effect if Firefly considers (in its reasonable discretion) that:
  - it is unable to adhere to, perform or implement any instructions issued by Customer due to the technical limitations of its systems, equipment and/or facilities; and/or
  - (b) to adhere to, perform or implement any such instructions would require disproportionate effort (whether in terms of time, cost, available technology, manpower or otherwise).
- 2.9. Customer represents and warrants on an ongoing basis that, for the purposes of Article 6 of the GDPR, there is, and will be throughout the term of the Agreement, a valid legal basis for the Processing by Firefly of Customer Personal Data in accordance with this Data Processing Addendum and the Agreement (including, any and all instructions issued by Customer from time to time in respect of such Processing).
- 2.10. Customer will indemnify and hold harmless Firefly and its employees, officers, directors and agents from and against any and all liabilities, losses, damages, costs, fines and other expenses (including legal costs and fees) arising from or relating to any breach by Customer of Paragraph 2.9. Any and all limitations on liability set out in the Agreement shall not apply to liability arising under or in connection with the indemnity set out in this Paragraph 2.10.

# 3. FIREFLY PERSONNEL

Firefly shall take reasonable steps to ensure the reliability of any Firefly Personnel who Process Customer Personal Data, ensuring that all such individuals are subject to confidentiality undertakings or professional or statutory obligations of confidentiality.

# 4. SECURITY

- 4.1. Taking into account the state of the art, the costs of implementation and the nature, scope, context and purposes of Processing as well as the risk (which may be of varying likelihood and severity) for the rights and freedoms of natural persons, Firefly shall in relation to Customer Personal Data implement appropriate technical and organisational measures to ensure a level of security appropriate to that risk, including, as appropriate, the measures referred to in Article 32(1) of the GDPR.
- 4.2. In assessing the appropriate level of security, Firefly shall take account in particular of the risks presented by the Processing, in particular from a Personal Data Breach.

# 5. SUBPROCESSING

5.1. Customer authorises Firefly to appoint Subprocessors in accordance with this Paragraph 5.



- 5.2. Firefly may continue to use those Subprocessors already engaged by Firefly as at the date of this Data Processing Addendum, subject to Firefly meeting within a reasonable timeframe (or having already met) the obligations set out in Paragraph 5.3.
- 5.3. Firefly shall give Customer prior written notice of the appointment of any new Subprocessor by updating the table shown at <a href="https://fireflylearning.com/subprocessors">https://fireflylearning.com/subprocessors</a> including reasonable details of the Processing to be undertaken by the Subprocessor. If, within ten (10) Business Days of receipt of that notice, Customer notifies Firefly in writing of any objections (on reasonable grounds) to the proposed appointment:
  - (a) Firefly shall use reasonable efforts to make available a commercially reasonable change in the provision of the Services which avoids the use of that proposed Subprocessor; and
  - (b) where:
    - (i) such a change cannot be made within thirty (30) Business Days from Firefly receipt of Customer's notice;
    - (ii) no commercially reasonable change is available; and/or
    - (iii) Customer declines to bear the cost of the proposed change,

either Party may by written notice to the other Party with immediate effect terminate the Agreement either in whole or to the extent that it relates to the Services which require the use of the proposed Subprocessor.

5.4. With respect to each Subprocessor, Firefly shall ensure that the arrangement between Firefly and the Subprocessor is governed by a written contract including terms which offer at least an equivalent level of protection for Customer Personal Data as those set out in this Data Processing Addendum (including those set out in Paragraph 4).

### 6. DATA SUBJECT RIGHTS

- 6.1. Taking into account the nature of the Processing, Firefly shall provide Customer with such assistance as may be reasonably necessary and technically possible in the circumstances, to assist Customer in fulfilling its obligation to respond to Data Subject Requests.
- 6.2. Firefly shall:
  - (a) promptly notify Customer if Firefly receives a Data Subject Request; and
  - (b) ensure that Firefly does not respond to any Data Subject Request except on the written instructions of Customer (and in such circumstances, at Customer's cost) or as required by applicable laws.



#### 7. PERSONAL DATA BREACH

- 7.1. Firefly shall notify Customer without undue delay upon Firefly becoming aware of a Personal Data Breach affecting Customer Personal Data, providing Customer with sufficient information (insofar as such information is, at such time, within Firefly's possession to allow Customer to meet any obligations under Data Protection Laws to report the Personal Data Breach to:
  - (a) affected Data Subjects; or
  - (b) the relevant Supervisory Authority(ies) (as may be determined in accordance with the Data Protection Laws).
- 7.2. Firefly shall at Customer's sole cost and expense co-operate with Customer and take such reasonable commercial steps as may be directed by Customer to assist in the investigation, mitigation and remediation of each such Personal Data Breach.

# 8. DATA PROTECTION IMPACT ASSESSMENT AND PRIOR CONSULTATION

Firefly shall provide reasonable assistance to Customer, at Customer's cost, with any data protection impact assessments, and prior consultations with Supervisory Authorities, which Customer reasonably considers to be required of Customer by Article 35 or Article 36 of the GDPR, in each case solely in relation to Processing of Customer Personal Data by, and taking into account the nature of the Processing by, and information available to, Firefly.

# 9. DELETION OR RETURN OBLIGATIONS

- 9.1. Subject to Paragraphs 9.2 and 9.5, upon the date of cessation of any Services involving the Processing of Customer Personal Data (the "Cessation Date"), Firefly shall immediately cease all Processing of the Customer Personal Data for any purpose other than for storage.
- 9.2. Subject to Paragraph 9.5, to the extent technically possible in the circumstances (as determined in Firefly's sole discretion), on written request to Firefly (to be made no later than fourteen (14) Business Days after the Cessation Date (the "Post-cessation Storage Period")), Firefly shall:
  - (a) return a complete copy of all Customer Personal Data within Firefly's possession to Customer by secure file transfer, promptly following which Firefly shall Delete all other copies of such Customer Personal Data; or
  - (b) Delete all Customer Personal Data then within Firefly's possession.
- 9.3. Firefly shall comply with any written request made pursuant to Paragraph 9.2 within sixty (60) Business Days of the Cessation Date.
- 9.4. In the event that during the Post-cessation Storage Period, Customer does not instruct Firefly in writing to either Delete or return the Customer Personal Data



pursuant to Paragraph 9.2, Firefly shall promptly after the expiry of the Post-cessation Storage Period either (at its option):

- (a) Delete; or
- (b) irreversibly render Anonymised Data,

all Customer Personal Data then within Firefly's possession to the fullest extent technically possible in the circumstances.

- 9.5. Firefly and any Subprocessor may retain Customer Personal Data where required by applicable law, for such period as may be required by such applicable law, provided that Firefly and any such Subprocessor shall ensure:
  - (a) the confidentiality of all such Customer Personal Data; and
  - (b) that such Customer Personal Data is only Processed as necessary for the purpose(s) specified in the applicable law requiring its storage and for no other purpose.

#### 10. AUDIT RIGHTS

- 10.1 Firefly shall make available to Customer on request such information as Firefly (acting reasonably) considers appropriate in the circumstances to demonstrate its compliance with this Data Processing Addendum.
- 10.2 Subject to Paragraphs 10.3 and 10.4, in the event that Customer (acting reasonably) is able to provide documentary evidence that the information made available by Firefly pursuant to Paragraph 10.1 is not sufficient in the circumstances to demonstrate Firefly's compliance with this Data Processing Addendum, Firefly shall allow for and contribute to audits, including on-premise inspections, by Customer or an auditor mandated by Customer in relation to the Processing of the Customer Personal Data by Firefly.
- 10.3. Customer shall give Firefly reasonable notice of any audit or inspection to be conducted under Paragraph 10.1 (which shall in no event be less than one (1) month's notice unless required by a Supervisory Authority pursuant to Paragraph 10.4(f)(i)) and shall use its best efforts (and ensure that each of its mandated auditors uses its best efforts) to avoid causing, and hereby indemnifies Firefly in respect of, any damage, injury or disruption to Firefly's premises, equipment, Personnel, data, and business (including any interference with the confidentiality or security of the data of Firefly's other customers or the availability of Firefly's services to such other customers) while its Personnel and/or its auditor's Personnel (if applicable) are on those premises in the course of any on-premise inspection.
- 10.4. Firefly need not give access to its premises for the purposes of such an audit or inspection:



- (a) to any individual unless he or she produces reasonable evidence of their identity and authority;
- (b) to any auditor whom Firefly has not given its prior written approval (not to be unreasonably withheld);
- (c) unless the auditor enters into a non-disclosure agreement with Firefly on terms acceptable to Firefly;
- (d) where, and to the extent that, Firefly considers, acting reasonably, that to do so would result in interference with the confidentiality or security of the data of Firefly's other customers or the availability of Firefly's services to such other customers;
- (e) outside normal business hours at those premises; or
- (f) on more than one occasion in any calendar year during the term of the Agreement, except for any additional audits or inspections which:
  - (i) Customer is required to carry out by Data Protection Law or a Supervisory Authority.
- 10.5. Customer shall bear any third party costs in connection with such inspection or audit and reimburse Firefly for all costs incurred by Firefly and time spent by Firefly (at Firefly's then- current professional services rates) in connection with any such inspection or audit.

#### 11. RESTRICTED TRANSFERS

- 11.1. Subject to Paragraph 11.3, to the extent that any Processing by any Subprocessor of Customer Personal Data involves a Restricted Transfer, the Parties agree that:
  - (a) Firefly (acting as agent for Customer) as "data exporter"; and
  - (b) Subprocessor as "data importer",
  - shall enter into the Standard Contractual Clauses in respect of that Restricted Transfer and the associated Processing in accordance with Paragraph 11.3.
- 11.2. In respect of any Standard Contractual Clauses entered into pursuant to Paragraph 11.1:
  - (a) Clause 9 of such Standard Contractual Clauses shall be populated as follows:
    - "The Clauses shall be governed by the law of the Member State in which the data exporter is established."
  - (b) Clause 11(3) of such Standard Contractual Clauses shall be populated as follows:



- "The provisions relating to data protection aspects for sub-processing of the contract referred to in paragraph 1 shall be governed by the law of the Member State in which the data exporter is established."
- (c) Appendix 1 to such Standard Contractual Clauses shall be populated with the corresponding information set out in Annex 1 (Data Processing Details); and
- (d) Appendix 2 to such Standard Contractual Clauses shall be populated as follows:
  - "The technical and organisational security measures implemented by the data importer in accordance with Clauses 4(d) and 5(c) are those established and maintained under Paragraph 4 of the Data Processing Addendum."
- 11.3. The Standard Contractual Clauses shall be deemed to come into effect under Paragraph 11.1 automatically upon the commencement of the relevant Restricted Transfer provided that Paragraph 11.1 shall not apply to a Restricted Transfer unless its effect is to allow the relevant Restricted Transfer and the associated Processing to take place without breach of applicable Data Protection Laws.

#### 12. CHANGE IN LAWS

- 12.1. In the event that there is a change in the Data Protection Laws that Firefly considers (acting reasonably) would mean that Firefly is no longer able to provide the Services (including any Processing and/or Restricted Transfer(s) of Customer Personal Data) in accordance with its obligations under Data Protection Laws, Firefly reserves the right to make such changes to the Services and to amend any part of this Data Processing Addendum as it considers reasonably necessary to ensure that Firefly is able to provide the Services in accordance with Data Protection Laws.
- 12.2. In the event that Customer considers (acting reasonably) that any required changes made either to the Services and/or this Data Processing Addendum pursuant to Paragraph 12.1 will cause material and irreparable harm to Customer may terminate the Agreement in its entirety upon written notice to Customer with immediate effect.

#### 13. ANONYMOUS DATA

Customer acknowledges and agrees that Firefly shall be freely able to use and disclose Anonymised Data for Firefly's own business purposes without restriction.

# 14. NO SPECIAL CATEGORIES OF PERSONAL DATA

- 14.1. Customer warrants and represents on an ongoing basis, and further undertakes, that it shall not (and shall ensure that its Personnel shall not) cause Firefly or its Subprocessors to Process any:
  - (a) Special Categories of Personal Data referred to in Article 9(1) of the GDPR; or



- (b) any Personal Data relating to relating to criminal convictions or offences.
- 14.2. Customer will indemnify and hold harmless Firefly and its employees, officers, directors and agents from and against any and all liabilities, losses, damages, costs, fines and other expenses (including legal costs and fees) arising from or relating to any breach by Customer of this Paragraph 14.
- 14.3. Any and all limitations on liability set out in the Agreement shall not apply to liability arising under or in connection with the indemnity set out in Paragraph 14.2.

# 15. ORDER OF PRECEDENCE

- 15.1. This Data Processing Addendum shall be incorporated into and form part of the Agreement.
- 15.2. In the event of any conflict or inconsistency between:
  - (a) this Data Processing Addendum and the Agreement, this Data Processing Addendum shall prevail; or
  - (b) any Standard Contractual Clauses entered into pursuant to Paragraph 11 and this Data Processing Addendum, those Standard Contractual Clauses shall prevail.



# **Annex 1 Data Processing Details**

This Annex 1 to the Data Processing Addendum includes certain details of the Processing of Customer Personal Data: as required by Article 28(3) GDPR; and (where applicable in accordance with Paragraph 11) to populate Appendix 1 to the Standard Contractual Clauses.

# Firefly Learning Limited's activities

- Firefly Leaning Limited is an educational technology company that provides learning and communication platforms to schools;
- The cloud based platforms allow teachers, students and parents to publish and access information. The platforms allow teachers to set homework, students to upload assignments, parents to track students' progress and so on, and facilitate ongoing communication (via email, SMS messaging, website access and other internet-based communication) between the Customer and the Data Subjects;
- The platforms are accessible via desktop and mobile app.

# Subject matter and duration of the Processing of Customer Personal Data

The subject matter and duration of the Processing of the Customer Personal Data are set out in the Agreement and the Data Processing Addendum.

# The nature and purpose of the Processing of Customer Personal Data

- Customer Personal Data (including Customer Personal Data belonging to children) is collected in the form of personal information provided by parents, teachers and students upon signing up to Firefly Learning Limited's website or app, or through their use of the Firefly Learning Limited's products, and from various other sources;
- The Customer Personal Data is used to provide, operate and maintain the Firefly Learning Limited products and to communicate features, developments and news relating to the same, as well as providing general customer service;
- Customer Personal Data may also be used to allow parents, students and teachers to communicate via the platform e.g. teacher's provision of feedback to students.

# The types of Customer Personal Data to be Processed

# Personal Data

- First and last names and professional titles;
- School/MIS codes and unique identifiers;
- Gender:
- Contact details including postal addresses, email addresses, phone numbers and fax numbers:
- Group memberships such as school Form, Year, Pupil type and other groups;
- Usernames, passwords, cookies and IP addresses;
- Demographic information (including user occupations);
- Other data fields as requested in forms created by the Customer;



• Content, documents and reply data created by the Customer and system users

The categories of Data Subject to whom the Customer Personal Data relates

- Customer's current and former personnel (e.g. teachers and administrators);
- Customer's current and former students
- Current and former parents, guardians, agents and other correspondence contacts linked to Customer's students
- Customer's prospective students and parents (optional)

# The obligations and rights of Customer

The obligations and rights of Customer are set out in the Agreement and the Data Processing Addendum.
